Investment Weekly

Commentary and Statistics

- Despite progress on tax reform, major stock indexes fell for the week, perhaps reacting to uncertainty about a government shutdown. Global bourses followed suit except for the UK, which posted gains. Oil and gold prices rose. The yield on the widely-watched 10-year U.S. Treasury note jumped from 2.36% to 2.49% to close the week.
- Congress and the White House cleared some unfinished business before leaving Washington for the holidays. Congress averted a shutdown by passing a stopgap spending bill to keep the government funded through January 19. Congress also approved funding for children's healthcare through March and passed a waiver to hold off automatic cuts to Medicare and some other federal programs should the tax-reform bill become law in 2017. With this technical fix in place, President Trump signed that bill into law before departing to spend the holidays at Mar-a-Lago.
- November new home sales reached 733,000, well ahead of the 655,000 expected and the fastest pace since July 2007. Housing starts increased 3.3% to a pace of about 1.3 million annualized in November, ahead of the 1.25 million consensus. The reading was the second highest in the last 10 years. Single-family starts increased 5.3% to 930,000, the highest in more than a decade. Multi-family starts fell 1.6%.
- The better data followed Monday's release of the NAHB Housing Market Index, which showed homebuilder sentiment jumped to the highest level in December since July 1999. The Citi US Economic Surprise Index has continued to push to new highs for 2017 and is now at levels not seen since early 2012.

- November personal income missed expectations, rising 0.3% against October's 0.4% increase, which was also the consensus. November personal spending was stronger, rising 0.6% vs. expectations for a 0.4% gain and October's downwardly revised 0.2% rise. November core PCE was up 0.1%, in line with expectations but down from October's 0.2% pace.
- November durable orders rose 1.3% m/m vs. consensus for a 2.0% rise and October's 0.4% monthly decline. New orders for nondefense capital goods excluding aircraft — a key proxy for business investment — dropped 0.1% m/m vs. consensus for a 0.5% rise.

Index Definitions

Bloomberg Barclays Global Aggregate Bond Index measures a wide range of global government, government-related, corporate and securitized fixed-income investments, all with maturities greater than one year.

Bloomberg Barclays High-Yield Bond Index tracks the performance of below investment grade U.S. dollar-denominated corporate bonds publicly issued in the U.S. domestic market.
