Investment Weekly

Commentary and Statistics

- U.S. equity indexes were slightly up at the end of a quiet week of trading with the S&P 500, Nasdaq and Dow Jones all experiencing slight gains. Oil and gold were both flat during the period. The 10-year U.S. Treasury note yield ended the week at approximately 2.54%.
- Fed Chair Janet Yellen spoke at the University of Baltimore, but did not discuss monetary policy. She said the U.S. labor market is the strongest it has been in a decade, thanks in part to accelerating wage growth and a low layoff rate. However, she did highlight some lingering challenges and noted the economy is growing more slowly than in past recoveries, while productivity growth has been disappointing.
- The final Q3 GDP reading came in at +3.5%, ahead of the 3.2% gain expected. The release noted acceleration reflected an upturn in private inventory investment and acceleration in imports.
- Markit's flash services PMI for December fell to 53.4, down from 54.6 in November and below the 55.1 consensus estimate. However, the report said the latest survey nonetheless revealed an acceleration in jobs growth for the third month running and a stronger degree of optimism about the business outlook.
- Existing home sales rose 0.7% month-to-month and 15.4% year-over-year in November to a 5.61M seasonally adjusted annual rate (SAAR), beating the 5.50M consensus. It was the fastest pace since February 2007. The median sales price rose 6.8% year over year to \$234,900.
- Durable goods orders fell 4.6% in November, worse than the 4.1% decline expected. However, orders ex-transport were up 0.5%, ahead of the 0.2% gain expected. Shipments were up 0.1% month over month following a 0.1% decline in October.

- Personal spending rose 0.2% in November, below the 0.3% gain expected and down from the 0.4% rise in October. Incomes were flat in November, below the 0.3% gain expected and down from the 0.5% rise in October. Wages and salaries fell 0.1%.
- Initial jobless claims rose 21K to 275K, higher than the 255K consensus estimate. It was the largest weekly rise since April 2014. The release noted no special factors impacted claims.

Bloomberg Barclays Global Aggregate Bond Index measures a wide range of global government, government-related, corporate and securitized fixed-income investments, all with maturities greater than one year.
