## Investment Weekly

### Commentary and Statistics

- U.S. equities climbed during the period with the S&P 500 and Dow Jones experiencing their greatest weekly gains since May. The Nasdaq also soared with its biggest rise since December. Oil jumped, gold was also up and the 10-year U.S. Treasury yield closed at approximately 2.33%.
- With 6% of S&P 500 companies having reported second quarter results, 80% have beaten earnings expectations while 83% have beaten sales expectations. According to FactSet, the second quarter blended earnings growth rate estimate for the S&P 500 is 6.8%. Zillow, NRG Energy and Rent-A-Center impressed this week; Delta Air Lines, Harley-Davidson and Blue Apron were among the disappointments.
- Federal Reserve Chair Janet Yellen commented to the House Financial Services Committee during the week speaking about strength in the labor market and the rebound in the broader economy following a sluggish Q1. In addition, she reiterated that recent lower readings on inflation are partly the result of a few “unusual reductions in certain categories of prices.” However, she also highlighted uncertainty about how much inflation will respond to tightening resource utilization.
- The headline Consumer Price Index (CPI) was unchanged month-to-month in June following a 0.1% decline in May, below consensus for a 0.1% increase. This pushed the year-over-year rate down to 1.6% from 1.9%, below the 1.7% consensus. Core CPI was up 0.1% month-to-month following a similar gain in May (and in April), below the 0.2% consensus. However, the year-over-year rate of growth remained unchanged at 1.7%.

- Headline retail sales were down 0.2% month-to-month in June following a revised 0.1% decline in May (was down 0.3%), below consensus for a 0.1% gain. Core retail sales (which feed into GDP) fell 0.1% following an unchanged flat reading in May, worse than consensus for a 0.3% gain. Sales dropped in six of the 13 major retail categories. Department store sales fell 0.7% after a 0.8% decline in May.
- The preliminary University of Michigan Consumer Sentiment Index reading for July came in at 93.1, weaker than the 95.0 consensus estimate and down from 95.1 in June. That is also down from the 13-year high of 98.5 recorded in January.

### Index Definitions

**Bloomberg Barclays Global Aggregate Bond Index** measures a wide range of global government, government-related, corporate and securitized fixed-income investments, all with maturities greater than one year.

**Bloomberg Barclays High-Yield Bond Index** tracks the performance of below investment grade U.S. dollar-denominated corporate bonds publicly issued in the U.S. domestic market.
