## Investment Weekly

### Commentary and Statistics

- U.S. equities posted gains for the period despite geopolitical tensions and disastrous flooding in Texas. The S&P 500, Dow Jones and Nasdaq all ticked up. Oil and gold also rose and the 10-year U.S. Treasury yield closed at approximately 2.17%.
- Hurricane Harvey pummeled Texas and the storm is considered to be one of the worst disasters in Texas history, with flooding impacting millions of people. In terms of market impact, gasoline futures jumped sharply during the week amid numerous refinery shutdowns and expectations of significant damage.
- U.S. equity markets once again prove to be resilient in the face of heightened geopolitical tensions. North Korea fired a mid-range ballistic missile over northern Japan, the first time they had done so since 2009. The Associated Press (AP) reported that the launch was likely to be the longest ever from North Korea.
- The move triggered angry responses from neighboring countries. The South Korean military raised its alert, while Japan's chief cabinet secretary said the missile test was an unprecedented threat and that Tokyo would respond firmly. It was also reported that Japan and the U.S. are looking to cut off North Korea's oil supply.
- Second quarter GDP was revised up to a 3.0% annual rate, better than the 2.7% expected and up from the initial growth estimate of 2.6%.
- Private payrolls increased 237K in August following an upwardly revised 201K gain (was previously 178K) in July. The release noted the goods-producing sector saw its best performance in months, with solid gains in both construction and manufacturing.

- Pending homes sales dropped 0.8% month-to-month in July vs. consensus for a 0.5% gain and June's 1.5% rise. They also dropped 1.3% year-over-year and have fallen on an annual basis for three of the past four months.
- Nonfarm payrolls increased 156K in August after a downwardly revised 189K gain in July (was previously 209K), below the 180K consensus. The unemployment rate pushed up to 4.4% from 4.3% in June, which was also the consensus. The labor participation rate remained unchanged at 62.9%. Average hourly earnings increased 0.1% month-to-month with a 2.5% increase year-over-year.

## Index Definitions

**Bloomberg Barclays Global Aggregate Bond Index** measures a wide range of global government, government-related, corporate and securitized fixed-income investments, all with maturities greater than one year.

**Bloomberg Barclays High-Yield Bond Index** tracks the performance of below investment grade U.S. dollar-denominated corporate bonds publicly issued in the U.S. domestic market.
